

JOURNEYMAN BEEKEEPER PUBLIC SERVICE REQUIREMENTS AND FORM:

Because of the magnitude of the program, we cannot certify each unit of public service; therefore we trust the integrity of the beekeeper to act in a responsible manner in filling out the Public Service Credit Form. It is your responsibility to document each public service work done by you. A detail explanation of how to submit your credits is written below. We reserve the right to question any unit of public service that is submitted and to disallow those that are questionable.

Five Public Service Credits required.

Types of Activity.

Presentation – Speaking to a group while using visual aids, such as posters, photographs, power point, observation hive, or beekeeping equipment etc....

Lecture – Speaking to a group without the use of visual aids.

Q & A – A question and answer session

Other – Miscellaneous events, such as publication of an article in a beekeeping journal, programs on beekeeping and related topics to school groups. Presentations to beekeeping groups. Serving as an officer/director of a county/local beekeeping organization, Construction of an exhibit or working at a beekeeping exhibit open to the public. Working at the NC state fair honey booth, or working at the NC Zoo Bee Exhibit. Multiple days only count as 1 credit. Mentoring a fellow beekeeper is good for 1 credit, even if you do several only 1 credit.

Example: June 1, 2014 spoke to the local Rotary Club luncheon, 47 adults in attendance, most were non-beekeepers, used Power Point and visual aids to make presentation about the process of getting honey into a jar, 1 hour.
